✓ Od 2018. moguće su KA107 stručne prakse, str. 32

- od 2 do 12 mjeseci
- dolazne i odlazne prakse
- moguća kombinacija SMS i SMP, ali u tom slučaju vrijede SMS pravila
- student dobiva Erasmus+ studentsku povelju, potpisuje Sporazum o učenju, organizacija primateljica izdaje Potvrdu o stručnoj praksi u roku od 5 tjedana
- finansijski iznosi isti su kao i za KA107 mobilnost u svrhu studija
- nema dodatne potpore za praksu kao u KA103
- nije moguća mobilnost nedavno diplomiranih studenata (*recent graduates*)
- bit će moguća izmjena SMS u SMP i obratno bez potpisivanja amandmana
- preporuka je kombinacija studija i prakse
- **a traineeship (work placement) abroad in an enterprise or any other relevant workplace²¹.** Traineeships abroad at a workplace are supported during short cycle, first, second, third cycle studies and, in the case of mobility within Programme Countries, within a maximum of one year after the student's graduation. This also includes the 'assistantships' for student teachers.





Odlazni student, SMP



Sudjelovanje neakademskog sektora

- ✓ Sudjelovanje organizacija koje nisu visoka učilišta (poduzeća, instituti, udruge, škole, profesionalna udruženja, tijela lokalne, regionalne samouprave...)

studenti – SMP

nastavnici – STA

nastavno i nenastavno osoblje – STT

- u prijavnom obrascu nije obvezno navesti ime poduzeća ili sl., ali navođenje neakademskog partnera može ojačati projektni prijedlog
- vrijede ista ograničenja o organizaciji primateljici kao i za KA103 – ne može biti EU institucija, specijalizirane agencije koje provode EU programe
- s neakademskim organizacijama ne potpisuje se međuinstitucijski sporazum već se koristi LA odnosno MA

Sudjelovanje osoblja

Mobilnost osoblja u svrhu podučavanja (STA)

neakademska organizacija → HEI (ne obrnuto!)

Mobilnost osoblja u svrhu osposobljavanja (STT)

HEI → neakademska organizacija (ne obrnuto!)



Neakademska organizacija u partnerskoj zemlji može poslati zaposlenike radi podučavanja (STA) na visoko učilište u RH, ali ne mogu primiti osoblje iz RH radi osposobljavanja (STT).

Osim u slučaju praksi, jedina mogućnost za neakademske organizacije u partnerskim zemljama je slanje osoblja radi podučavanja (STA) na visoko učilište u RH.



Sudjelovanje osoblja – primjer 1





Osim u slučaju praksi, jedina mogućnost za neakademske organizacije u partnerskim zemljama je slanje osoblja radi podučavanja (STA) na visoko učilište u RH.

²² Any traineeship will be considered as a "traineeship in digital skills" when one or more of the following activities are practised by the trainee: digital marketing (e.g. social media management, web analytics); digital graphical, mechanical or architectural design; development of apps, software, scripts, or websites; installation, maintenance and management of IT systems and networks; cybersecurity; data analytics, mining and visualisation; programming and training of robots and artificial intelligence applications. Generic customer support, order fulfilment, data entry or office tasks are not considered in this category.
