

Erasmus Charter for Higher Education Selection 2019

- ✓ Serbia new Programme Country
- ✓ All existing grant agreements with Serbian institutions from all calls up to and including the 2018 call remain valid and will be implemented until completion (KA107-2017 and KA107-2018)
- ✓ As of the 2019 call Serbian HEIs will be able to fully participate with the status of an organisation located in a Programme Country























New Programme Country

✓ Serbia becomes a fully-fledged Programme Country from call 2019 and will no longer qualify as an eligible Partner Country under ICM new

Brexit update

This statement has been issued by UK Government.

UK-EU Withdrawal Agreement

The UK Government has made it clear that it values international exchanges and collaboration in education and training. The joint report on progress during phase 1 of negotiations between the UK and the EU states that 'following withdrawal from the Union, the UK will continue to participate in the Union programmes financed by the Multiannual Financial Framework (MFF) 2014-2020 until their closure'.

Erasmus+ is one such programme and under the terms of the Withdrawal Agreement UK organisations' eligibility to apply for Erasmus+ funds during this period will remain unchanged for the duration of projects under the current programme. On this basis, the UK Government encourages UK organisations to continue to bid for Erasmus+ funding.

Government underwrite guarantee in a 'no deal' scenario

The UK Government is confident that the UK and the EU will ratify the Withdrawal Agreement, however to prepare for the unlikely event of a 'no deal' scenario, the Government announced in August 2016 that it would underwrite the payment of awards for UK applicants for successful bids to EU funding. This covers all successful bids for Erasmus+ funding that are submitted before the UK exits the EU, including under the current 2019 Call for Proposals, which was published on 24 October, where planned projects can continue.

In July 2018, the Government also announced an extension of this underwrite quarantee for certain EU programmes, including Erasmus+, covering funding applied for after the UK's exit, provided that the terms under which UK organisations could be eligible for post-exit participation are agreed

✓ Invited staff from enterprises

- Minimum duration 1 day
- No minimum number of teaching hours

From 2 days (5 days from and to Partner Countries) to 2 months, excluding travel time. In mobility between Programme Countries, the minimum 2 days must be consecutive. In the case of invited staff from enterprises, the minimum duration for mobility between Programme Countries is 1 day.

Duration of the activity

A teaching activity has to comprise a minimum of 8 hours of teaching per week (or any shorter period of stay). If the mobility lasts longer than one week, the minimum number of teaching hours for an incomplete week should be proportional to the duration of that week. The following exceptions apply:

- There is no minimum number of teaching hours for invited staff from enterprises.
- If the teaching activity is combined with a training activity during a single period abroad, the minimum number of hours of teaching per week (or any shorter period of stay) is reduced to 4 hours.

- ✓ Projects start date: **1 August 2019** (instead of 1 June)
- ✓ Projects duration: 24 or 36 months



The applicant must choose the duration at application stage, based on the scale of the project and on the type of activities planned over time.		
Mobility between Programme Countries: 16 or 24 months.		
Mobility between Programme and Partner Countries: 24 or 36 months.		
To the National Agency of the country in which the applicant organisation is established.		
Applicants have to submit their grant application by 5 February at 12:00 (midday Brussels time) for projects starting on:		
 1 June of the same year, for mobility projects between Programme Countries 1 August of the same year, for mobility projects between Programme and Partner Countries

Croatian Bank joins Erasmus+ **Master Loan Scheme**

- **Privredna Banka Zagreb** (PBZ, part of the Intesa Group) decided to participate in the Erasmus+ Master Loan Scheme
- The new agreement concerns a portfolio worth EUR **0,6 million** in student loans and should benefit some 40 master's students (through an Erasmus+ guarantee of EUR 97.200).
- PBZ will initially focus on **outgoing master students**, but may at a later stage consider widening its offer also to incoming students.
- No collateral or third party guarantee will be required for the Erasmus+guaranteed Master loans, which will be offered at favourable terms (interest rate around 4,5%).
- The new offer will be available from early 2019 onwards, and the portfolio can be easily scaled up by the EIF.























Removing obstacles -**Taxation issues**

Amendments to the Income Tax Act was adopted by the Croatian Parliament and published in the Official Gazette of the Republic of Croatia ("Narodne novine", 106/2018) on the 30th November 2018.

Članak 7.

U članku 17. stavku 2. točki 8. iza riječi: »porez na dohodak« umjesto točke stavlja se zarez i dodaju točke 9., 10. i 11. koje glase:

- 11. potpore djetetu za školovanje do 15. godine života odnosno do završetka osnovnoškolskog obrazovanja, koje poslodavac isplaćuje djetetu umrlog radnika ili djetetu bivšeg radnika kod kojeg je nastupio potpuni gubitak radne sposobnosti, uz uvjet da bivši radnik ne ostvaruje primitke iz članka 21. ovoga Zakona.«.
