# Corrigendum to the 2021 Erasmus+ Programme Guide

This Corrigendum comprises changes related to:

- Clarification on the top-up amount for traineeships for students and recent graduates from outermost regions and OCTs within higher education mobility projects
- Clarification on the possibility for additional rounds for KA2 Cooperation Partnerships
- Clarifications regarding the type of eligible organisations and conditions for the organisation of not-for-profit European Sport Events

## CHANGES RELATED TO MOBILITY PROJECTS FOR HIGHER EDUCATION STUDENTS AND STAFF

Page 62:

**Clarification on the top-up amount for traineeships for Students and recent graduates from outermost regions and OCTs**

### Students and recent graduates from outermost regions and OCTs

Considering the constraints imposed by the remoteness from other Programme Countries and the economic level, students and recent graduates studying or having studied in higher education institutions located in outermost regions of EU Member States, and Overseas Countries and Territories (OCTs) associated to EU Member States will receive the following higher amounts for individual support:

From	To	Amount
Outermost regions and OCTs	Programme Countries and Partner Countries from regions 5 and 14.	700 EUR per month

The top-up amounts for students and recent graduates with fewer opportunities ~~and for traineeships~~ will not apply in this case. **The top-up amount for traineeships applies.**

## CHANGES RELATED TO PARTNERSHIPS FOR COOPERATION

Page 178:

**Clarification on the possibility for National Agencies to organise additional rounds for KA2 Cooperation Partnerships in the fields of education, training and youth.**

## CHANGES RELATED TO NOT-FOR-PROFIT EUROPEAN SPORT EVENTS

### Page 253

Both public and private organisations may be applicants. Both public and private organisations can participate in the project.

#### ELIGIBILITY CRITERIA:

<b>Who can apply?</b>	<p>Any public <b>body</b> or <b>private</b> organisation, with its affiliated entities (if any), active in the field of sport, established in a Programme Country. For example, such organisation can be (non-exhaustive list):</p> <ul style="list-style-type: none"> <li>• a public body in charge of sport at local, regional or national level;</li> <li>• a sport organisation at local, regional, national, European or international level;</li> <li>• a National Olympic Committee or National Sport confederation;</li> <li>• an organisation representing the 'sport for all' movement;</li> <li>• an organisation active in the field of physical activity promotion;</li> <li>• an organisation representing the active leisure sector;</li> <li>• an organisation active in the field of education, training or youth.</li> </ul>
<b>What types of organisations are eligible to participate in the project?</b>	<p>Any public <b>body</b> or <b>private</b> organisation, with its affiliated entities (if any), active in the field of sport, established in a Programme Country.</p>

### Page 256

The activities must take place in each Programme Country involved in the Not-for-profit European Sport Event.
